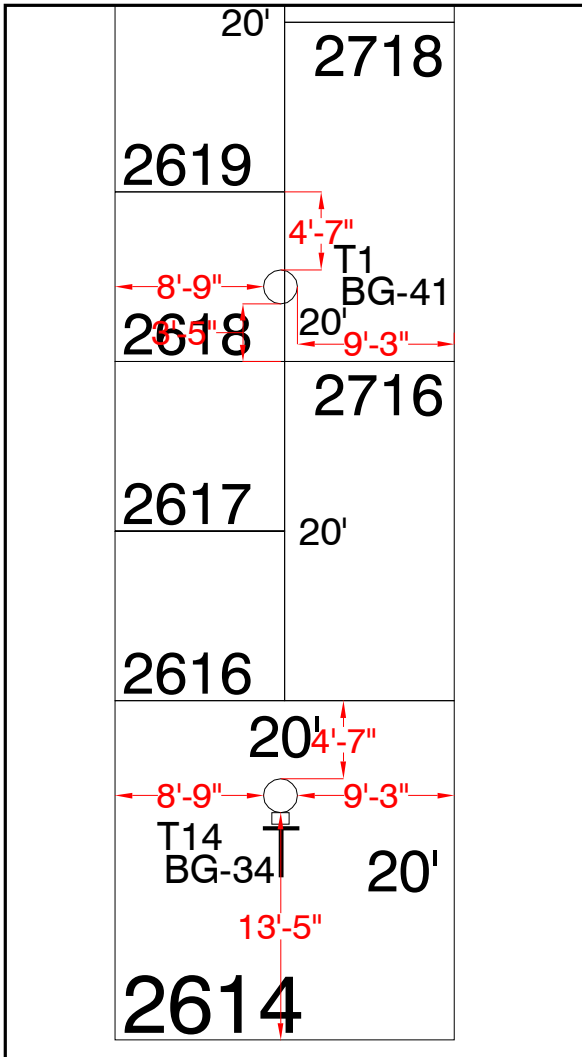

Ceiling Restrictions: LEVEL 1

- NEITHER HANGING SIGNS NOR MULTI-LEVEL BOOTHS ARE PERMITTED IN G HALL OR THE LOWER LEVEL LOBBY DUE TO THE HEIGHT LIMITATIONS.

FHC	<ul style="list-style-type: none"> - FIRE HOSE CONNECTION - FIRE HOSE CONNECTION LOCATIONS VARY. REFER TO FLOOR PLAN/ ELEVATIONS FOR FHC LOCATIONS.
FE	<ul style="list-style-type: none"> - FIRE EXTINGUISHER CABINET - FE CABINETS VARY ON COLUMNS. REFER TO FLOOR PLAN/ ELEVATIONS FOR FE LOCATIONS.
FS	<ul style="list-style-type: none"> - FIRE ALARM STROBE - FS VARY IN HEIGHT FROM FLOOR.
FV	<ul style="list-style-type: none"> - FIRE HOSE VALVE - FIRE HOSE VALVE PIPE COMES FROM THE CEILING.
S	WALL SCONCE

- IT IS THE RESPONSIBILITY OF THE EXHIBITOR TO PROVIDE ACCESS TO FIRE EQUIPMENT WITHIN THEIR BOOTH.
- FIRE EXTINGUISHERS MAY BE BLOCKED ONLY WHEN A TEMPORARY FE IS PROVIDED.

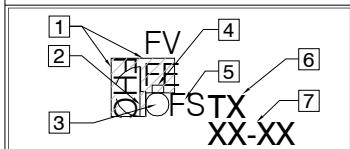

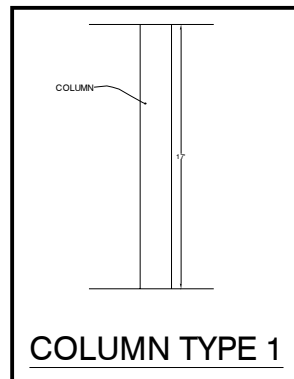
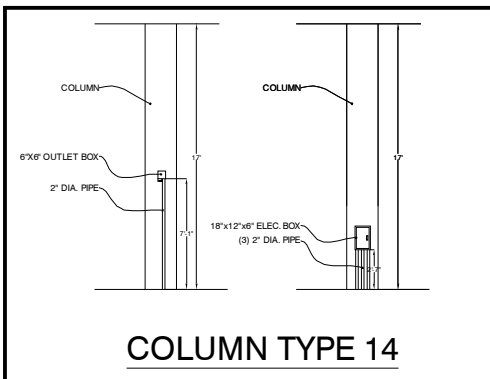
