

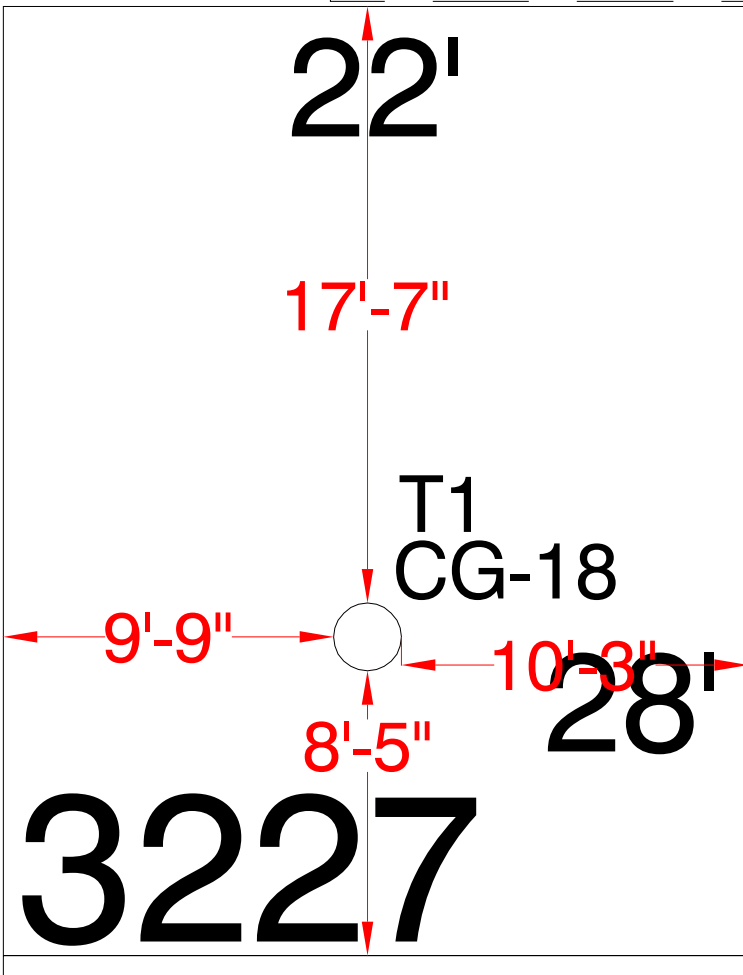

- FIRE EXTINGUISHERS MAY BE BLOCKED ONLY WHEN A TEMPORARY FE IS PROVIDED.

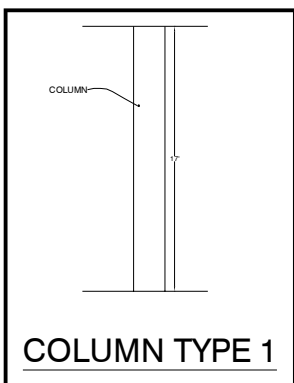
